## **TERMS & CONDITIONS GOVERNING EXHIBITION AGREEMENT**

1. The conditions set forth on this form apply to all objects lent to Womankind and cannot be altered, changed, waived or otherwise amended except as agreed upon in writing.
2. Womankind will exercise the same care with respect to your work as it does the safekeeping and handling of all works lent and/or donated to Womankind.
3. Unless otherwise agreed upon, the cost of transportation and packing of the work will be the responsibility of the artist.
4. In the event of a loss it will be the responsibility of the artist to establish to their insurance company the declared fair market value of the item in question.
5. It is understood that the general public and media may photograph objects shown.
6. Any object lent to Womankind for exhibition shall remain in its possession for the time specific on the face of this form.
7. Womankind has the sole discretion as to choice of, duration of, and in what manner objects will be displayed. Womankind has the right to determine what written and interpretive materials will accompany the exhibition,
8. In the event of any conflict between this agreement and any writings, forms, or documents of the lender, the terms of this agreement shall be controlling.
9. Womankind has the right to use materials for internal and external public relations, media and promotion.
10. In the event of a sale, the split will be 50% benefit the artist, 25% donated to Womankind and 25% donated to The Studios of Key West. Artist may also choose to donate their object.

The above conditions shall apply to all objects on display and cannot be altered, changed, waived or otherwise affected except by written agreement of both parties. In signing this agreement, the undersigned warrants, represents and certifies that he or she is the legal owner or authorized agent of the legal owner of the property described on this form.
